## Fla. Firm Haber Law Elevates 3 Attys To Partner Amid Growth

Law360 (November 24, 2025, 4:47 PM EST) -- Miami-based Haber Law promoted three attorneys to its partnership after seeing growth in its Miami-Dade, Broward and Palm Beach markets.

Attorneys Kyle Alonso, Annie Schneider and Justin Smith will start their new roles as partners on Jan. 1, the firm announced last week. The firm said it has had more than 50% growth in attorney headcount over the past two years.

The promotions are "a function of our firm's growth, as well as our commitment to lawyers in the firm and bringing them up through the ranks, and them getting more experience and promoting them as they continue to grow," managing partner David B. Haber said in an interview with Law360 Pulse Monday.

"We believe that growth on both external and internal levels are important, and we believe very strongly that these people are the, in essence, next generation of lawyers within the firm," Haber said.

The firm said it has strengthened its leadership ranks to meet increasing demand for legal services. It also recently opened up shops in Palm Beach Gardens and Fort Lauderdale.

Haber said all three of the new partners were tapped in part because of their character.

"They have incredible character, professionalism, work ethic, and they have a passion for the law and helping people," Haber said.

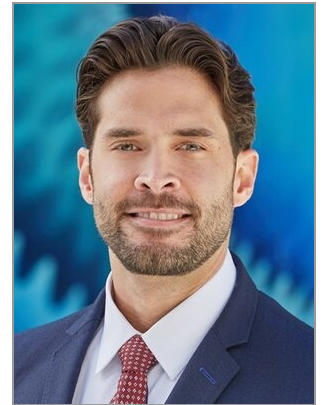
Alonso has been with Haber Law for two years and focuses his practice on civil litigation and community association law. He serves as a general counsel to condominiums, homeowners associations and businesses.

"What I enjoy about condominium work is the daily solution-oriented work that you have to provide for your clients," Alonso said in an interview with Law360 Pulse.

He added: "I also like the varied nature of the condominium practice. It's not typically that lawyers get to practice in such wide range of [areas]. So you can deal with torts, personal injury to an extent, and construction and board governance. And I think the interplay between the corporate world and real estate is something I really thrive in."

A 2015 graduate of the University of Miami School of Law, Alonso also holds a bachelor's degree in finance from Florida State University.

Schneider has been with Haber Law for four and a half years and handles business fraud, contractual

disputes for individuals and corporate entities, complex commercial cases, partnership disputes and probate litigation. She's worked on matters involving wrongful death, complex torts and general liability.

She got her start in the Miami-Dade State Attorney's Office, where she tried dozens of misdemeanor and felony cases to verdict. That experience overlaps some with her work now on the plaintiffs side of commercial litigation, she said.

"This was something that was always part of the plan," Schneider said in an interview with Law360 Pulse Monday. "I wanted to be able to help people, not just in the criminal context.

"When I started in commercial and I first interviewed at Haber, I was told that about 90% of the work we do is plaintiff work, which was very important to me," she said. "I'm in the litigation practice group at Haber, and what I'm able to do here is to serve clients that, for instance, have big problems, as far as business disputes, as far as civil theft, family members stealing from one another. We do a lot of trust litigation, and we deal with a lot of fraud."

Schneider is a graduate of Yeshiva University's Benjamin N. Cardozo School of Law.

Smith has been with Haber Law for three years and focuses his practice on representing community associations, and counseling condominium and homeowners association clients on community association law.

He helps clients with day-to-day operations, elections, recalls, special assessments, assessment collection, vendor and service agreements, contract negotiations, amendments to governing documents, and interpretation and application of laws.

Smith also works closely with boards of directors and managers.

Representing condo associations "was intriguing to me, purely for the aspect of working more with the management companies and working with the board members for the associations," Smith said in an interview with Law360 Pulse Monday. "The board members are volunteers. These are unpaid people who really just need assistance with the legal aspect of running their community. And I felt like that was something that I really would excel at because I like working with people, and this is the perfect opportunity to have those sorts of interactions with a client that you know truly needs legal advice."

A graduate of Florida Coastal School of Law, Smith earned a bachelor's degree in journalism, in advertising, at the University of Georgia.

Haber Law is home to nearly 40 attorneys at its three offices. It focuses on complex business litigation, construction law, condominium association and homeowners association law, real estate and transactional law.
